ConnectLife's Buffalo Bills Suit Seats Raffle

Official Rules

- **2. DEADLINES:** The raffle for all ConnectLife donor centers and mobiles starts at 12:01 am on Friday, August 1, 2025, and ends at 11:59 pm on Wednesday, December 31, 2025, ("Sweepstakes Period"). All entries must be made no later than Wednesday, December 31, 2025.
- 3. ELIGIBILITY REQUIREMENTS: The Sweepstakes is open to all legal residents of the United States, and the District of Columbia aged 18 years of age or older at the time of entry who register to donate as set out below. An actual donation is not necessary for an individual to be entered into the Sweepstakes. Presenting donors who complete the registration process remain eligible for entry even if they are deferred from donating at that time. A valid email address is required to qualify for the sweepstakes. platelet donations between August 1, 2025, and December 31, 2025, and complete the donor registration process. A valid email address is required to qualify for the raffle.

- **5. ENTRY FREQUENCY:** Two whole blood donations, one double red cell donation or four platelet donations during the specified timeframe counts as one entry in the drawing.
- **6. PRIZE DRAWING:** One (1) winner will be selected in a random drawing. The drawing date will be on or before Friday, January 2, 2026, from all ConnectLife eligible donations at centers and mobiles.

The winner will be notified by telephone and/or email (which must be provided during the registration process), at ConnectLife's discretion. The prize may be claimed by, and will be awarded only to, the individual identified on the donor entry registration form. The winner will be required to complete and return a prize acceptance and release, liability release and consent to use winner's name and likeness without further compensation, except as prohibited by law.
